1099 Reporting Act Repealed

On April 14, President Obama signed into law the HR 4; 1099 Act, which repeals both the expanded Form 1099 information reporting requirements mandated by last year's health care legislation and also the 1099 reporting requirements imposed on taxpayers who receive rental income enacted as part of last year's Small Business Jobs Act (PL 111-240). The Senate approved the bill on April 5, and the House voted in favor of it on March 3.



Colorado Secretary of State No Longer Sending Postcard Notification

Effective January 1, 2012 Colorado's Secretary of state will no longer send postcard notification to business' that their "Periodic Annual Reports" are due. The report is required by law (section 7-90-501, C.R.S.)

You can receive notifications regarding changes, reports and due dates by signing up for the Secretary of State's email notification service at [Secretary of State](#)

Make sure your e-mail address is on-file with the Secretary of State by clicking on the link above. Don't risk penalties.
